CHAPTER FOUR CONTINENTAL SHELF

Article 17

Subject to articles 23/2 and 24 of this Law, the continental shelf of the State comprises the seabed and subsoil of the submarine areas extending beyond its territorial sea and considered a natural prolongation of its ladit territory to the outer edge one continental margin, or to a distance of 200 nautical miles from the baselines from which the breadth of the territorial sea is measured where the outer edge of the continental margin does not extend up to that distance

Article 18

The State shall exercise over its continental shelf sovereign rights for the purposes of exploring and exploiting its natural resources.
