### **DESCRIPTION OF REQUIREMENTS**

The United Nations Verification Mission in Colombia (UNVMC) has a requirement for the provision of Customs Clearance and Related Services for vehicles arriving in maritime shipments and Covered warehouse at destination (Bogotá). The expected duration of the contract is for an initial term of one (1) year. The services are required for maritime/seaports of entry and exit in Colombia based on mission-mandated demands.

La Misión de Verificación de las Naciones Unidas en Colombia (UNVMC) requiere la prestación de servicios de despacho aduanero y servicios relacionados para vehículos que arriban por vía marítima, así como almacenamiento/bodegaje cubierto en destino (Bogotá). Los servicios se requieren en los puertos marítimos de entrada y salida en Colombia según las demandas establecidas por el mandato de la misión.

d. El contratista deberá realizar la importación bajo franquicia de 36 vehículos que llegarán al país por vía marítima al puerto de Buenaventura en diferentes envíos parciales. El término de negociación desde origen es DPU, por lo que el contratista deberá encargarse de la nacionalización de los vehículos (despacho aduanero), la toma de huellas (números de motor, VIN, etc.) si aplica, y la recepción de la carga en instalaciones de almacenamiento/bodegaje cubierto designadas, donde los vehículos permanecerán hasta nuevas instrucciones.
