THE DELIMITATI

The Government of the Republic of Cyprus and the Government of the United Kingdom, jointly, the "two Parties";

Desiring to strengthen cooperation between them in the field of maritime law and fisheries;

Recognizing the importance of the Economic Zone for the development of the area;

Recalling the provisions of the United Nations Convention on the Law of the Sea, 1982, and the United Nations Convention on the Exclusive Economic Zone, 1978;

Basing themselves on the principles of equity and justice, and of the law of the sea applicable to the area;

Have agreed as follows:

(a) The delimitation of the Economic Zone between the two Parties is effected by the line defined in paragraph (b) below;

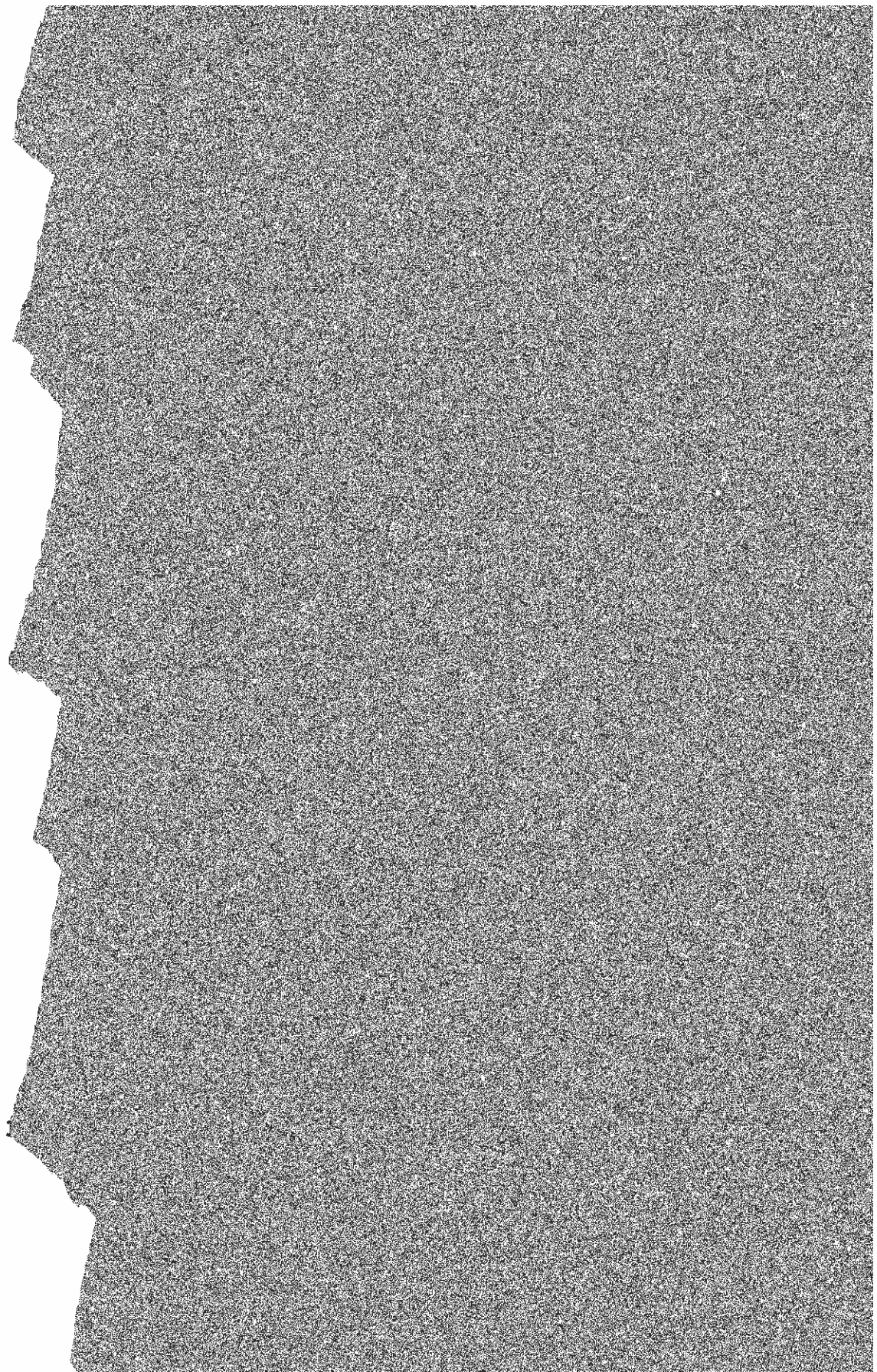

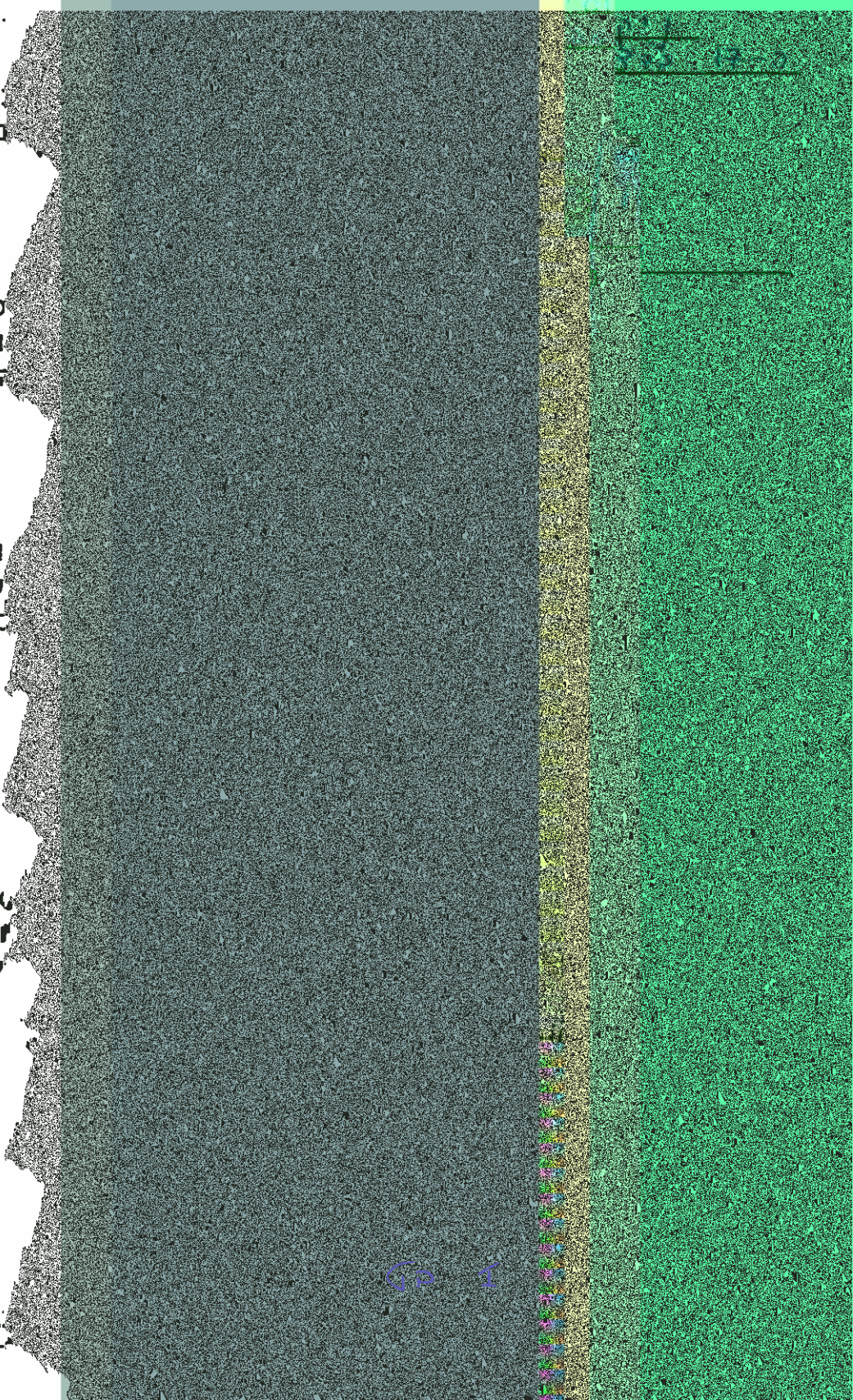

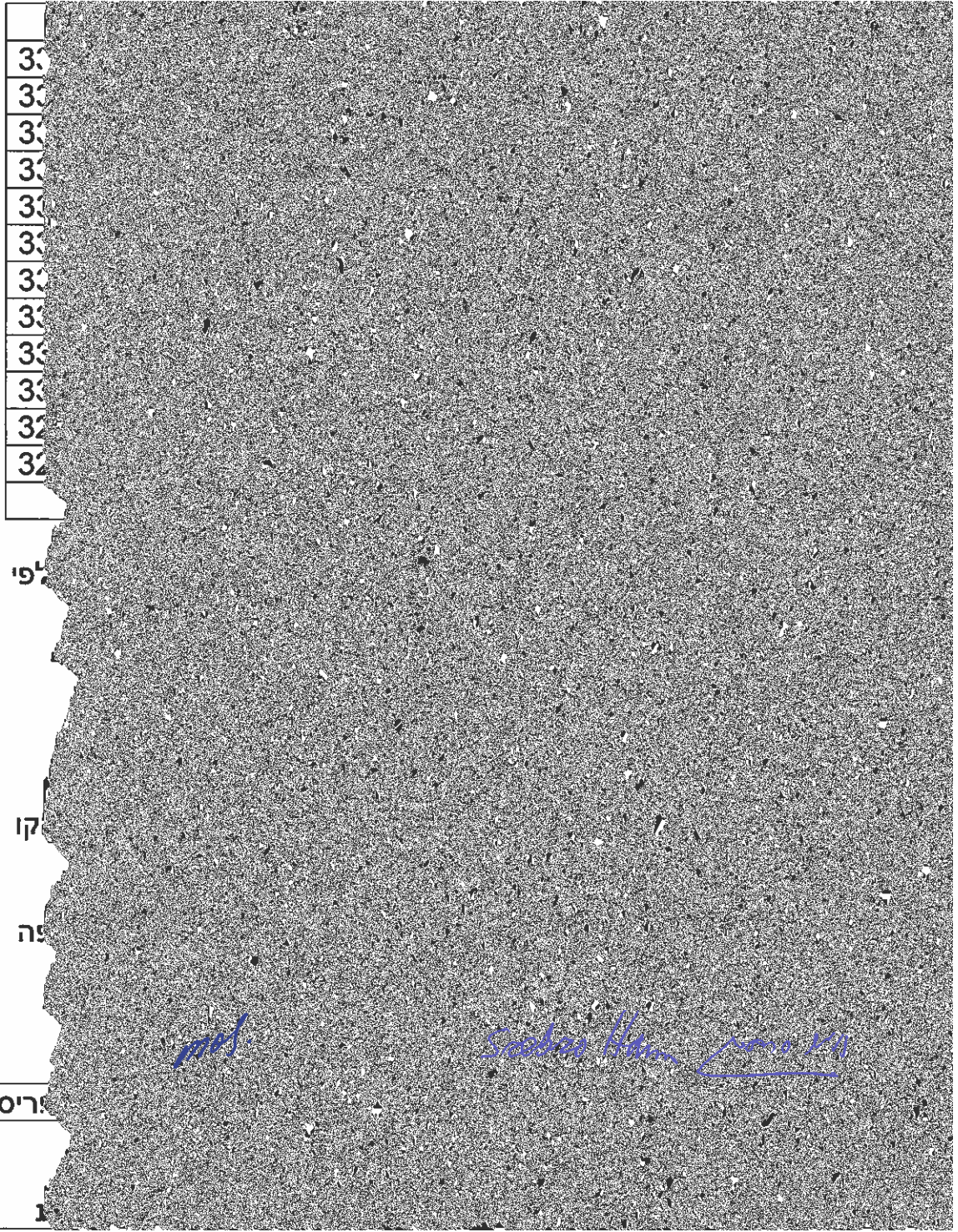
