Excellencies,  
Distinguished delegates,  
Ladies and gentlemen,

The Caribbean Regional Seminar has now drawn to a close. On behalf of the Special Committee, I would like to offer my sincere thanks to all participants for their presence here, and for their contributions to the deliberations of the Seminar. I am especially pleased that we have had a lively exchange of views fuelled by the inputs of the Caribbean representatives, since this region has after all been the focus of this seminar.

We, as the Special Committee, have a special responsibility towards the people of the Non-Self-Governing Territories within our purview, and it is indeed a privilege to have had the opportunity to hear directly from you over these past days. I am confident that the Special Committee's work will have been greatly enriched by this encounter. We will certainly continue to give serious consideration to the views and suggestions you have expressed, with the intention that they will be taken into account by the Special Committee in the future.

Our special thanks also go to the other distinguished speakers who kindly accepted the Special Committee's invitation to participate in a limited time available for the preparation of the Seminar, and who shared with us their valuable expertise and enlightening insights.

During the three days of deliberations, we have heard from representatives of the Non-Self-Governing Territories, permanent observers and non-permanent members of the General Assembly, a representative of an administering Power, Members of the Special Committee, and other Member States. Time does not permit me to encapsulate the richness of the debate.

What has been made abundantly clear to us during these past days is that different Territories have different needs, different expectations and different concerns. It is obvious that some Territories are quite satisfied with the present arrangements that exist between them and their administering Power, while others expressed dissatisfaction and a need for further progress. It is incumbent upon the Special Committee to ensure that

spectrum, and it is its duty to find ways forward to deal with this reality on a case-by-case basis, always keeping as our paramount consideration the wishes and wellbeing of the peoples of the Non-Self-Governing Territories.

Before I conclude, I would like to express our sincere appreciation to the Government of Grenada for hosting and organizing this seminar. Foreign Minister Nimrod's presence at our opening ceremony was a great honor. I would also like to thank the United Nations and his deputy, Ms. Margot Saint John.
