

Great Britain and Northern Ireland is still ongoing. Each year, throughout this first half of the Third Decade, the Committee adopted consensus resolutions that continued to (1) recognize the existence of a sovereignty dispute between Argentina and the United Kingdom, describing the case as a “special and particular” colonial situation; (2) request its only two parties to resume bilateral negotiations to find a solution to it; (3) duly taking into account the “interests” of the population of the islands.
