Mr. Chairman,

[Introduction]

Criminal accountability of United Nations ficials and experts covers a broad range indiawful conduct, from fraud, theft, to sexual abuse and exploitation learly some conduct is more serious than other, but all unlawful conduct by United Nations ficials and experts on mission is unacceptable and has a detrimental effect on the fulfilment of the mandate of the United Nations, it's Funds and Programs.

Let mestress that, even though prosecution is sometimes difficult, no United Natificial stands above the law. It is our responsibility ensure that they are held accountable for their actions, as much as anyone else.

We have been discussing this topic for more than ten years, and although progress has been made, for instance in the reporting of criminal misconduct, we seem to be unable to prevent criminal misconduct and hold those responsible countable This situation can no longer continue, and we need to step up our efforts in order to ensure criminal accountability of UN officials and experts on mission.

The topic of criminal accuntability of UN officials and experts on mission is closely linked to the topic of combating Sexual Exploitation and Abuæred sexual harassment. We fully support the SecretaryGeneral'sstrategy to combat Sexual Exploitation and Abuæred no 2017. We commend the work done so far and strongly encourage further work.

Over the past years, new Administrative Instructions have been issued, new policies and measures have been adopted and implemented including a zerotolerance policy There is a SecretaryGeneral's bulletin on *Prohibition of discrimination, harassment, including sexual harassment, and abuse of auth*ority', there is one on *Special measures for protection from sexual exploitation and abuse*', on *Protection against retaliation'*, and many more.

On paper the right polies are in placeBut if policy alone was successful, we would not be discussing this issue todaWe therefore support the recent announced strategy aimed at bringing about a cultural and operational chorento improve dramatically how the United Nations addresses sexual exploitation and abuse, and sexual harassment

The fact that there is still a culture of silence concerning sexual exploitation and abuse, sexual harassment and criminal misconduby officials of the united Nations, its funds and programs, is deeply troubling.

The Netherlands is committed to eliminate Sexual Exploitation and Abusethe Prime Minister of the Netherlands has joined the Secretespeneral's circle of leadership. This is a sign of our strong commitment to this issue.

As a donor to the United Nations, its Funds and grams my Government no longer was to be seen as enabling, financing and approving such conduct. Therefore, before financially contributing to funds and pograms, we will require.
