## Mr. Chairman,

The Czech Republiconsides the universal jurisdiction to be an important and usterfoll for bringing the perpetrators of the crimers der international law justice. It is the nature and severity of these crimes that shock thoe science of the international community as a whole and that is the reason for which is in the interest of all States to prosecute and punish those responsible for it without any connection of such State to the crime commited ball fight against impunity for these crimes and denial of safe haven of its perpetrators is also justified by the fact that such crimes violate universal values our view, exercising universal jurisdiction does not mean only holding the perpetrators of such crimes active jubitat also providing justice for victims and strengthening respect for international law.

In this context, we would like to recall that niversal jurisdiction is a generally recognized principle of public international law. We believe that definingsits pe and application is purely legal question and should not be burdened by political considerations which are unavoidable within the Sixth Committelelaving said that, we commend the work of the Working Groupand note the progress that has been made it is establishmen. Although some elements of the scope and application of the universal jurisdiction as they appear in the Informal paper have been agreed upon, there are still many differences among States on key aspects such assues of customary natre of universal jurisdiction, in absentia trials and so on. Hence, if seems that the discussions in the Working Group can go ad infinite trials of the working Group which does not allow for substantive progress.

However, this topic is a practical one and therefogal certainty regarding the scope and application of universal jurisdiction among international community is very desirable. Czech Republicas one of the Statesatt has incorporated universal jurisdiction in its national law would welcome further progress in this respectour opinion, the topicmerits thorough legal analysis which can be best carried out by an independent expert body such as the International law Commission. The Commission can dedicate more time for its consideration and use its knowledge from other studies that have relevance to this Ftoptimermore, by its nature the ILC an hardly be labelled as political and therefore any outcome of its raight enable to advance discussions on those aspects where differences among States prevail.

On the basis of the above entioned, the Czech Republic has in the last years proposed to refer this topic to the International Law Commission. In 2018 the Commission itself noted the lack of meaningfulprogressof the discussions in the Working Group due to political disagreements concerning potential selective and arbitrary application of universal jurisdiction. At the same time, the Commission of the need for clarification of certain aspects concerning universal jurisdiction and decided to include the topic of universal criminal jurisdiction in along-term programme of work. Accordingly to Commission would limit its work only to some legal concernshich can serve as guidance the Sixth Committee. It is also elaborate expert proposals that would allow States to have a clearer legal basis from which the discussions may be started in order to reach a compromise.

Referring this topic to the Commssion would demonstrate commitment of the Sixth Committee to the idea of strengthening its interaction with the Commission. The Sixth Committee would still retain final responsibility for the treatment of this topic, because the outcome of the Commission's work on the universal jurisdiction would necessarily back to the Sixth Committee for any action the Committee would then consider appropriate. Therefore, as in the previous years, we propose to refer this issue to the ILC to prepare a study on this topic. We remain firmly convinced that exploring such an avenue would bring positive outcomes.
