Romania fully aligns with the statement delivered on behalf of the European Union and its Member States and would like to add the following remarks in its national capacity.

Draft article 6

Draft article 6 is of paramountsignificance as it imposes on Statesconcreteobligations to enact the appropriate criminal legislation which allows for the establishment and exercise of jurisdiction to the alleged offender, as well as for the provision for appropriate penalties king into consideration the grave nature of the crimes

We would like to share some evant information regarding our national legislation.

The Romanian Criminal Code regulates the crimes against humanity in Article 439, which follows closely the definition provided in Article 7 of the Rome Statutaend Draft Article 2on Prevention and Purishment of Crimes Against Humanit These crimes are punishalize the Romanian Criminal Code by appropriate penalties, taking interconsideration their grave nature life imprisonment or imprisonment for 15 to 25 pears and banfrom exercising certain ghts.

We are also very much in favoro the nonapplication of any statute of limitation for these offences as included in para. 5 of draft article 5. Romania has already takenaspolicy decisionAccording to Article 153 paragraph 2 letter a) the Romanian Criminal Code, genocide incress against humanity and war crimes shall be subject to any statute of limitation Romania is a party to the 968 Convention on the NorApplicability of Statutory Limitations to War Crimes and Crimes against Humanity and to the 1974 European Convert on the NorApplicability of Statutory Limitation to Crimes against Humanity and War Crimes

Draft article 7

The preliminary measures pided in draftarticle 9 are quite common in national proceedings with a view to avoiding the risk of flight by the alleged offender, as well as further criminal acts. In light of the seriousness of the crimes against humanity, the inclusion of such **aiquicade** ems fully justifed.

At the sametime, we consider thathese preliminary measures must equally obsetime standards related to fair treatment and full protection of the rights, vided in draftarticle 11.
