Mr. Chairman,

TheNon-Aligned Movement (NAM) underlines obligation of all States to ensure the security and safety of the members and premises of diplomatic and consular missions as well as their inviolability in accordance with international law, the provisions of the Vienna Convention on Diplomatic Relians, and the Vienna Convention on Consular Relations as well as relevant UN General Assembly resolutions

The Movement tiges States to take every measure necessary to secure the implementation of the rules of international law governing diplomatic relations and in particular to take all necessary measures in conformity with their international obligations effectively to ensure the protecton, security and safety of adiplomaticand consulamissions well as representatives officially present the territory under their jurisdiction, including particular measures to prohibit in their territories

The NAM expresses its concernegarding the continued violation of and failure to respect the inviolability of diplomatic and consular missions as well as representative including the serious threat presented by such violations to the maintenance of normal and peaceful international relations which are necessary foo peration among States

While placing emphasion the sanctity of the diplomatic status of all foreign representatives before receivistates, the NAM lsourges all States to take all appropriate measures in order to the indisuse of this position as well as diplomatic and consular premises in violation of relevant international law as well as internal laws and regulations of receiving States.

The Movementurgesstates to cooperate closely, inter alithrough contacts between the diplomatic and consultations and the receiving State. In this regard, the Movementcourages States to design practical measures enhance the protection, security and safety of diplomatic and consular missions and presentatives well as exchange information on the circumstances all serious violations thereofin cases where a dispute arises in connection with a violation the principles and rules of international law concerning the inviolability of diplomatic and consular missions and representates, the Movement encourages the concentration States makeuse of the means for peaceful settlement of disputes appropriately

The NAM, while expresing its sympathy for the victims of illegal acts committed against diplomatic and consular representatives and missions as well as against representatives and missions to international intergovernmental organizations do officials of such organizations addition those whoare affected by the misconduct of the holders of immunities and privilegesurges that where appropriate and applicable all victims and affected persorbse compensated.

The NAM also underlines the critical role of the host countries of Nations Headquarters and Offices in United preserving multilateralism and facilitating multilateral diplomacyong withintergovernmental normaking processe Furthermore, the Movementals upon all States which host the United Nations Headquarters and Offices to facilitate the presence of the representatives of the Member States in the relevant meetings of the United Nationsaccordance with their obligations under the related Headquate Agreements and the Vienna Convention on diplomatic relationsast but not least, itecalls that the provisions of the Headquarters Agreement shall be applicable irrespective of the bilateral relations existing between the Governments and the Host Country.
