As known, despite their interactions, international criminal law, international human rights law and international humanitarian law clearly differ in their scope. On the other hand, the draft articles focus on the crimes against humanity. Therefore, according to Tüfekciye, determining whether there is a non-refoulement obligation the competent authorities of a given state should take into account the pattern of acts listed in draft Article 3 instead of Article 3 JURVV IODJUDQW RU PDVV YLRODWLRQV RI K LQWHUQDWLRQDO KXPDQLWDULDQ ODZ.

The terms "human rights violations" or "violations of humanitarian law" are broader than the term "crimes against humanity". Therefore, reference to a consistent pattern of gross, flagrant or mass violations of human rights or of serious violations of international humanitarian law goes beyond the scope of the draft in question.
