Introduction

- 1. The Applicant serves as an Administrative Assistant the United Nations Interim Force in Lebanon (UNIFILa) the FS-5 level. On 8 November 2014, he filed an Application contesting a decisionade on 25 April 2014 not to select her for the Temporary Job Opening (TJO) Contracts Management Assistant the FS-5 level advertised a BJO/2014/011.
- 2. The Respondent filed a Reply **26** Decembe **2**014 in which he asserted that the Application is without merit and s not receivable ationae temporae.
- 3. The Tribunal, in accordance with art9 1of the Tribunal's Rules of Procedure has determine that an oral hearing is not required in determining the preliminary issue of receivability and will rely on the Parties' pleadings and written submissions.

Procedure

- 4. On 4 February 201,5by Order No.046 (NBI/2015), the Applicant was directed to file hersubmissions in response to the issue of receivability by March 2015.
- 5. The Applicant filed the said submissions on 3 March 2015

Facts

- 6. On 21 March 201,4the temporary position of Contracts Management Assistant was advertisemental Assistant was advertised as a constant was a constant was advertised as a constant was adver
- 7. The Applicant applied for the position on 28 March 2014.
- 8. A two-member interview panel was convened to assess the candidates comprising of the Hiring Managea, female staff member external to the work unit where the job opening was located and a staff member from Human Resources who served asænofficiomember of the panel.

- 9. The Applicant and sevenheter staff members applied for the sition, took written tests and undertook competency based interviews.
- 10. On 28 April 2014 the Hiring Manager transmitted the selection memorandum to the Chief Human Resources Officer recommending that the staff member wb scored the highest on the written test be selected for the position.
- 11. On 27 June 2014the selected candidate declined the position. Another candidate was offered the position but, on 18 July 2014, also declined the offer.
- 12. Following the second candidatedscision to decline the position, UNIFIL management decided that the position would be filled from the roster by a staff member appointed on a longer basis and that the recruitment would take place from January 2015.

- 14. On 27 June 2014, the Applicant received an email from Matagement Evaluation Unit (MEU) with a letter attached imeference to hemanagement evaluation request M(ER). The letter advised the Applicant on the applicable deadlines for submission of her case to the Dispute Tribunal as follows:

Please also note that, pursuant to Statile 11.2 (d), the management evaluation inyour case is to be completed within 45 days of receipt of your request, or no later that gust 2014. If there is any delay in completing the management evaluation, the MEU will contact you to so advise. In any event, please be advised that, pursuant to Statile 11.4 (a) the 90 day deadline for filing an application to the UNDT, should you wish to do so, will start run from 9 August 2014, or the date on which the management evaluation was complete if, earlier, unless the deadline sheen extended by the Secreta eneral to facilitate efforts or informal resolution under the auspices to 60 of the Ombudsman.
