5. Despite all these challenges, we must still approach the LDC5 Conference with a lot of hope, optimism and high expectations. In particular, we must continue to pin our hopes on the realization of 2030 Agenda and the SDGs -- wherein all UN Member States and the stakeholders -- have pledged to "leave no one behind".

6. We are all cognizant, however, that at the moment, too many people in LDCs are at risk of being left behind, and the situation is exacerbated by the fact that we have less than 10 years to change this dire situation. In my view, the true success of the 2030 Agenda hinges heavily on the achievement and concrete progress made by vulnerable groups of States like the LDCs.

7. We should also remain hopeful that, since the Decade of Action for the SDGs coincides with the New Programme of Action for the Least Developed Countries, there is an opportunity to shape an effective and strengthened response to enable the LDCs to recover lost ground on the SDGs implementation as well as increase efforts to confront the many areas where progress is needed.

In my previous capacity as Vice-President of ECOSOC at its 2021 Session, I presided together with the President of the General Assembly over a joint thematic event convened by the two Principal Organs on 18 June 2021, under the theme of: *"Diversifying the Financing Toolbox to Enhance Investment in Least Developed Countries"*. The event highlighted a number of key factors that require our attention, among them;

- The need for a comprehensive financing mechanism for the LDCs to better manage risk and provide support in times of crisis, and also
- A call for a reformed and strengthened international financial system that can provide more effective and targeted support for the LDCs.
