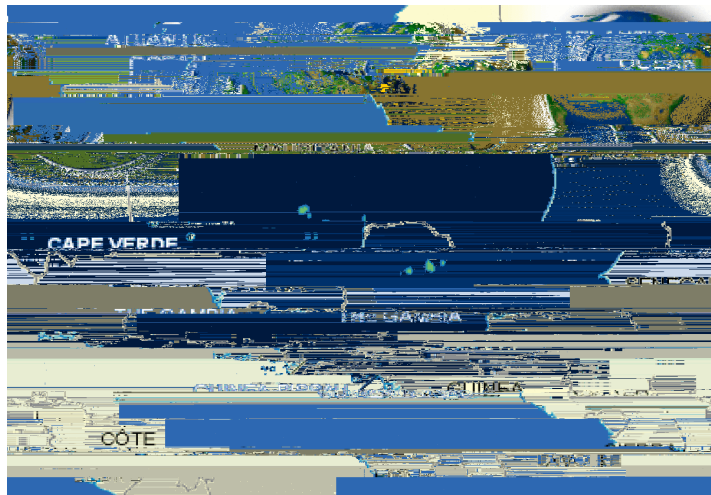

The Republic of Cabo Verde is an island country spanning an archipelago of 10 volcanic islands in the central Atlantic Ocean. It forms part of the Macaronesia ecoregion, along with the Azores, Canary Islands, Madeira, and the Savage Isles. **Praia**, on Santiago, is the capital, which is located in nearby Senegal and is the nearest point on the continent.
