development. This is important because land has been a central factor in conflicts in Solomon slands.

+nother factor that impedes economic development and the effective delivery of services, and therefore increasing opportunities for conflict, is corruption. %y Government has responded to this by drafting an +nti(Corruption bill, accompanied by a ! ational +nti( Corruption Strategy. The bill " ill be tabled in parliament in the near future.

Climate change is another issue that could potentially trigger conflicts. Solomon slands, like other, acific sland countries, is at the forefront of the impacts of climate change. So far, "e have already lost five islands as a result of sea level rise. \* e no" have the burden of relocating people to other parts of country, mostly in and around urban centers that are already cro" ded.

Such relocations could cause conflicts as people compete for land and other resources. \* e have developed and implement adaptation programmes to mitigate the impact of climate change and natural disasters.

&ut, "e ackno" ledge that climate change is a global challenge that "ill also re.uire global solutions. Solomon slands is therefore committed to the , aris +greement. Climate change is not 'ust an environmental issue. t is also an economic, political, cultural and legal issue that has implications for sustainable peace.

This "eek, during the >cean Conference, you "ill hear from our colleagues from other, acific sland countries about the significance of the >cean to our countries. The vast, acific >cean is a source of revenue, food, security and identity for our island countries.
